MINUTES OF THE PRIEST RIVER CITY COUNCIL – 04/17/23

REGULAR MEETING

<u>OPENING</u> – Mayor Connolly called to order the regular meeting of the City Council at 5:30 pm on Monday, April 17, 2023, at the Priest River City Hall Council Chambers, 552 High Street, Priest River, Idaho.

3. PUBLIC HEARING CONTINUATION FROM MARCH 27, 2023 TO CONSIDER THE FOLLOWING PLANNING AND ZONING APPLICATION:

A. CANDACE STEPHENS-STUART HAS APPLIED TO SUBDIVIDE THE 3.05-ACRE LOT 2 OF BRENNAN'S RUN INTO SIX (6) SINGLE FAMILY LOTS AND ONE (1) COMMON AREA.

THE PROPERTY IS GENERALLY LOCATED BETWEEN EASTSIDE ROAD AND THE PRIEST RIVER WITH RIVER'S END DRIVE DIVIDING THE PROPERTY.

Mayor Connolly opened the public hearing at 5:31 pm. Planning and Zoning Administrator Quayle explained the reason for the public hearing continuation and presented the amended proposed conditions to the Mayor and City Council. Lengthy discussion ensued.
