A. CONTROL #2024-10-01 - MOSS - REQUEST FOR PAVEMENT STRIPING ON FOURTH STREET AT HIGHWAY 2 INTERSECTION

B. CONTROL #2024-10-04 – STICKELMEYER – REQUEST FOR CODE EXEMPTION TO ALLOW PIGS ON R-1 ZONED PROPERTY OF LESS THAN 1 ACRE

Ashely Stickelmeyer was in attendance to present her request to the Council. Lengthy discussion ensued.

Council Member Brower made a motion to deny the request for a code exemption to allow the keeping of pigs on an R-1 zoned lot in the city of less than one acre. Council Member Turner seconded the motion. After consideration, the motion passed unanimously.

C. THE VILLAGE AT RIVER VIEW RIDGE - SECURITY BOND RELEASE REQUEST
