ORDINANCE NO. 551

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR FISCAL YEAR BEGINNING OCTOBER 1, 2012, APPROPRIATING THE SUM OF TWO MILLION ONE HUNDRED FORTY-TWO THOUSAND SIX HUNDRED TWENTY-NINE DOLLARS AND NO CENTS (\$2,142,629.00) TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF PRIEST RIVER FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

Be it ordained by the Mayor and Council of the City of Priest River, Bonner County, Idaho:

SECTION I: That the sum of TWO MILLION ONE HUNDRED FORTY-TWO THOUSAND SIX HUNDRED TWENTY-NINE DOLLARS AND NO CENTS (\$2,142,629.00) be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Priest River, Bonner County, Idaho for the fiscal year beginning October 1, 2012.

SECTION II: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

SECTION III: That a general tax levy on all taxable property within the City of Priest River be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2012.

SECTION IV: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION V: This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of the Priest River Times, a

newspaper of general circulation in the City of Priest River, and the official newspaper of said City.
