AN ORDINANCE OF THE CITY OF PRIEST RIVER, BONNER COUNTY, IDAHO, AMENDING ORDINANCE NO. 598, THE APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019, ALLOWING AND APPROPRIATING LOCAL STRATEGIC INITIATIVE GRANT FUNDS IN THE AMOUNT OF \$1,000,000.00 DESIGNATED FOR THE DOWNTOWN REVITALIZATION PROJECT; DIRECTING THE CITY CLERK TO FILE A CERTIFIED COPY OF THIS ORDINANCE WITH THE IDAHO SECRETARY OF STATE; AND PROVIDING FOR AN EFFECTIVE DATE.

Be it ordained by the Mayor and Council of the City of Priest River, Bonner County, Idaho:

SECTION I: That Ordinance No. 598, the Appropriations Ordinance for the City of Priest River, Idaho, for the fiscal year commencing October 1, 2018 and ending September 30, 2019, be, and the same is hereby amended as follows:

That an additional amount of \$1,000,000.00 be appropriated out of the revenues from a Local Strategic Initiatives Grant in the sum of \$1,000,000.00, to be used for authorized activities in the General Fund.
